KUHS - Academic - Granting of one time exemption to the Colleges, from inspection for continuation of provisional affiliation for the Academic year 2021-2022.- Decision No. 62.16 of the Governing Council - Implemented - orders issued

ORDER

The 23rd Governing Council meeting vide decision read (1) above has decided to conduct inspections for granting Continuation of Provisional Affiliation in every two years in all colleges except those colleges where first batch of UG/PG/Super speciality courses has not passed out. It is also decided that in such colleges inspection will be conducted in every year till the first batch has passed out . The Governing Council also decided to conduct random inspections in colleges against whom complaints are received / deficiencies are reported as and when required.

2. As per the above norm, University has to conduct inspection once in every two years in colleges which are having a track record of having no deficiency reported during consecutive inspections. Citing the prevalence of COVID 19 pandemic, many of the faculty deputed for physical inspection in the colleges for the grant of Continuation of Provisional Affiliation, has expressed their unwillingness to conduct inspections due to travel restrictions, non-availability of conveyance and considering the risk of being get infected.

3.Considering the situation due to COVID 19 Pandemic, the Governing Council meeting held on 26.12.2020 vide decision read (2) above has decided to give one time exemption to the Colleges satisfying any of the following conditions from inspection for the grant of continuation of provisional affiliation for the Academic year 2021-2022.

- i. The colleges whose first batch of all courses are passed out and no major/minor deficiencies were pointed out during inspection conducted for the grant of continuation of provisional affiliation during the academic year 2019-20 and inspections were not conducted for the grant of continuation of provisional affiliation during 2020-2021.
- ii. The colleges whose first batch of all courses are passed out and no major deficiencies/no major deficiencies but with minor deficiencies/no deficiencies were pointed out during inspection conducted for the grant of continuation of provisional affiliation during the academic year 2020-21.
- iii. The colleges which will satisfy any of the above two conditions, if exempting the norm that the first batch of the students of all courses admitted in the College under EWS quota in various UG,PG courses and /or under super speciality courses (starting/ enhancement of seats) were passed out.

4. The Hon'ble Vice Chancellor has accorded sanction to implement the Governing Council decision read(2) above.

5.Orders are issued accordingly.
