ORDER

As per the Section 26 (i) of the Kerala University of Health Sciences Act, 2010, the Board of Examinations (BoE) shall be the authority for conducting the examinations and making policy decisions in regard to organising and holding examinations, improving the system of examinations, appointing the paper-setters and examiners and for preparation of the schedule of dates for holding examinations and declaration of the results, subject to the control and review of the Governing Council.

2. The members of the Board of the Examinations shall be appointed as per the Section 26(3) of the KUHS Act, 2010 and as per Section 26(3)(iii) the members of the Board of Examinations consist of the Deans of the Faculties concerned with the examination.

3. The Board of Studies of the various Faculties of the University has been constituted consequent to the expiry of their term of office vide paper read as 2nd above and as per Section 13(2), Chapter III of the Kerala University of Health Sciences Act, 2010, the Hon'ble Vice Chancellor has nominated the Deans of various Faculties from among the members of the Faculty vide paper read as 3rd above.

4. Accordingly, in exercise of the powers conferred under Section 26(3)(iii) of Kerala University of Health Sciences Act, 2010 (Act 4 of 2011) and in accordance with Sub Clause (iii) Administrative Powers, Chapter II of the Kerala University of Health Sciences First Statutes, 2019 and as per order vide paper read 4th above, the Hon'ble Vice Chancellor has accorded sanction for the reconstitution of the Board of Examinations of the University with the following members in their respective capacities:-
