ORDER

As per the Section 26 (i) of the Kerala University of Health Sciences Act, 2010, the Board of Examinations (BoE) shall be the authority for conducting the examinations and making policy decisions in regard to organising and holding examinations, improving the system of examinations, appointing the paper-setters and examiners and for preparation of the schedule of dates for holding examinations and declaration of the results, subject to the control and review of the Governing Council.

2. The members of the Board of Examinations shall be appointed as per Section 26(3) of the KUHS Act, 2010. In accordance with Section 26(3)(v) of Kerala University of Health Sciences Act, 2010 (Act 4 of 2011) , one Principal other than Dean of Faculty, is appointed by the Hon'ble Vice Chancellor to be a member of the Board of Examinations. Consequently, "Dr. Beena V.T, Principal , Government Dental College, Thiruvananthapuram was nominated for this position. However, following her promotion to Joint Director of Medical Education (General), the Hon'ble Vice Chancellor has appointed Dr. Shameena P.M, Principal of Government Dental College, Thrissur, in place of Dr. Beena V.T, as the new member of the Board of Examinations.

3. Accordingly, in exercise of the powers conferred under Section 26(3)(v) of Kerala University of Health Sciences Act, 2010 (Act 4 of 2011) and in accordance with Sub Clause (iii) Administrative Powers, Chapter II of the Kerala University of Health Sciences First Statutes, 2019, Hon'ble Vice Chancellor has accorded sanction for the reconstitution of the Board of Examinations of the University by including **Dr. Shameena P.M, Principal, Government Dental College, Thrissur**, as a new member.

4. As per Clause (5) of Chapter VIII of KUHS First Statutes, 2013, the members of the Board of Examinations other than ex- officio members, shall hold office for a term of four years from the date of nomination. The other member(s) of the Board of Examinations whose term of office has not expired as
