KUHS-Academic- MES College of Nursing, Perinthalmanna - Application for provisional affiliation for enhancement of seats of B.Sc. Nursing Course for the academic year 2025-26 -rejected - Orders issued.

ORDER

The Principal, MES College of Nursing, Perinthalmanna, vide paper read (1), had submitted application for the seat enhancement of B.Sc. Nursing course from 70 to 100, for the academic year 2025-26.

Upon detailed examination of the application, it was found that college had not obtained NOC from government for the applied seats, as stipulated in the notification issued by university, and the login credentials to submit the application for seat enhancement were secured by submitting an old No Objection Certificate, for 75 seats, issued in 2021.

The University, vide paper read (2) above, accordingly directed the principal to furnish an explanation on the matter.

The principal, vide paper read (3) above, furnished explanation admitting that due to the limited period for submitting the online application, the login credentials were secured by submitting the old NoC (issued in 2021) in order to meet the submission deadline, and expecting to receive the updated NOC prior to the closure of the submission window.

Thus, admittedly, the college has failed to produce a valid NoC, as essential document to consider the application, and the login credentials were secured by using an old No Objection Certificate for 75 seats, issued by the Government in 2021.

As per the statute (5) (vii) (1) of the amendment of the first statute on the matter of affiliation of colleges - On receipt of the application, it shall be scrutinized by the office. Incomplete or defective applications and applications not supported by necessary documents shall be summarily rejected and the list of such rejected applications shall be published in University Website and intimation sent to the applicant by post or e mail. In the event of such rejection, the application fee shall not be refunded.

In the instant case, the application was not supported by a valid NoC from the Government, a necessary document for submission of application.

Accordingly, the following orders are issued:

The application submitted by MES college of Nursing, Perinthalmanna, for enhancement of seats in B.Sc. Nursing Course from 70 to 100 for the academic year 2025-26 is hereby rejected in accordance with the Statutory Provision as detailed above.
