ORDER

1. As per the order read ^{1st}, various Faculties of the Kerala University of Health Sciences were constituted for a period of three years with effect from 21.07.2018. The Dean, Faculty of Medicine, Dr.K.Mohanan, Professor & HOD of Radiodiagnosis, MES Medical College, Perinthalmanna (included in the capacity as Chairperson of BOS -Medical PG) has assumed the charge of new Vice Chancellor, Kerala University of Health Sciences, Thrissur and the Faculty member, elected from among the members of Board of Studies Medical Clinical UG, Dr. K.K.Purushothaman, HOD of Paediatrics, Govt. Medical College, Thrissur as the Chairperson Medical Clinical UG was nominated as the Chairperson BOS-Medical-Clinical-UG on account resignation of Dr. C.P.Vijayan vide order read 2nd above.

2. As per the Section 39 (11) of Kerala University of Health Sciences Act, 2010, the Hon'ble Vice Chancellor has nominated **Dr. Chandini.R, Professor of General Medicine, Govt. Medical College, Kozhikode as the Chairperson of Board of Studies Medical -PG and Dr. P.P. Lakshmanan, Professor and HOD, Dept. of General Surgery, Malabar Medical College and Research Centre, Kozhikode as the Faculty member** from among the members of Board of Studies Medical Clinical UG against the existing vacancy in the Faculty of Medicine .

3. As per the section 30 (4) of the KUHS Act 2010, the chairpersons of each Boards of studies shall be in the member of Faculties concerned.

7. Order read 1st above stands modified to the above extent and Orders are issued accordingly.


