ORDER

1. As per the order read (1st) above, various Faculties of the Kerala University of Health Sciences were constituted with effect from 21.07.2018. As per the Section 39 (9) of the Kerala University of Health Sciences Act 2010, if the person nominated, elected, appointed or co-opted to an authority or body remains absent without prior permission of the authority or body for three consecutive meetings, he shall be deemed to have vacated his membership and he shall cease to be a member from the date of third such meeting in which he has remained absent.

2. Dr. R.Krishnakumar, Head of Department, Paediatric Cardiology, Amritha Institute of Medical Sciences, Kochi and Dr. Sukesh Nair, Professor of Haematology, CMC, Vellore, who were nominated by Hon'ble Vice Chancellor as the members in the Faculty of Medicine (subject experts, preferably from out side State) have not been attending three consecutive meetings. Accordingly their membership in the Faculty of Medicine has been ceased.

3. As per the Section 30 (5) (iv) and 39 (11) of the KUHS Act 2010, the Hon'ble Vice Chancellor has nominated the following persons as members in the Faculty of Medicine against the existing vacancies due to the cessation of membership of the persons mentioned in para (2) above.
