DISSERTATION NOTIFICATION

Plagiarism certificate shall be attached as part of the Dissertation.

- The submission shall include mandatorily, an undertaking (by the candidate) indicating that the document has been prepared by the candidate and that the document is the original work of the person and is free from plagiarism.
- The submission shall include a certificate from the Guide / supervisor that the work is free from plagiarism.
- In case of quoting one's own work a declaration regarding self-plagiarism shall be submitted.
- If the researcher is quoting a work which has more than one author including the researcher, the declaration regarding self-plagiarism from the co-authors shall be submitted.
- The submission shall include a certificate of approval from an approved plagiarism detection software, stating the percentage of similarities detected. Plagiarism tools approved by University Grants Commission shall be used to detect plagiarism.
- Admissible level of similarities: 10%
